

## CLP's 81st Annual Meeting Review

We would like to thank everyone that came out to the 2018 CLP Annual Meeting. We had 193 registered members in attendance, and the Lion's Club prepared and served 323 Sloppy Joe suppers. Entertainment was provided by the Two Harbors Ukulele Group. Community Partners organized a health fair that had many area businesses dedicated to helping our community's seniors.

Our youngest members were able to register for a chance to win one of four youth bicycles. Below is one of our happy winners. They also had the op-



portunity to play in the pool or watch a movie while the business meeting was in session. District 4 Board Member, Alis Stevens, was re-elected by acclamation. In District 3, Gregory Lien was elected to the Board of Directors.

Operation Round Up Board Member, Judy Martell, distributed almost \$18,000 in grant funds to local nonprofit organizations and civic groups.

CLP had two guest speakers on hand at this years annual meeting. Ellen Anderson, Director of the University of Minnesota's Energy Transition Lab; and, Jim Horan, Director of Government Affairs and General Counsel for the Minnesota Rural Electric Association.

Ellen focused her discussion on energy production and consumer consumption, and the inefficiencies that exist in the generation and distribution process. She emphasized how large capacity storage could aid in the integration of renewable energy on to the utility grid, and lessen the need for expensive peaking plants.

Jim focused his discussion on energy

legislation. He discussed the importance of the passage of the Local Democracy legislation, and touched on potential changes in the upcoming legislative session. Of course, so much is in flux, it is too early to predict what will happen.

At the end of their discussions, they held a joint Q&A, fielding questions from the audience.

**Democratic Member Control.** Cooperatives are democratic organizations that are controlled by their members. It is what sets co-ops apart from other businesses. The members, who are actually owners, actively participate in setting policies and making decisions. Member account number six hundred fifteen thousand seven hundred eighteen. This participation all begins with a vote.

You, as members of District 3, made an important decision on Wednesday, April 18, 2018, when you elected Greg Lien as your new District 3 Director. This change takes place after you consistently re-elected Jim Anderson to 9 consecutive terms to the Co-op Light & Power Board. You also re-elected Alis Stevens as your District 4 Director. Your electric co-op is run under the premise of one member-one vote; and, you elect your District Director to represent your interests. Your elected district representative, in turn, is accountable to the membership to make decisions that uphold these interests. You see, we all have very important roles to play in this place

we call a co-op.

Voting in local elections is also critical, because they are the roots of state and national elections. In 2016, rural America played a big part in our national elections; in fact, 500,000 MORE rural voters cast their ballots than in 2012. Men and women, like you, in small towns and communities across our country went to the polls to ensure their voices were heard, and elected officials took notice. But elections matter EVERY year, not just in presidential years.

In 2018, Co-op Light & Power is urging you to join with 42 million members of electric cooperatives around the country, and remind our elected officials that rural issues matter. Electric co-ops provide coverage for 88 percent of our nation's counties. They are a foundation in their communities and their members can make a difference in lending their voices to issues like rural infrastructure and broadband, and maintaining access to affordable, reliable electricity.

When we go to the polls with the cooperative principle of "Concern for Community" in mind, we instantly improve our political system. It's a system designed to produce a government "of the people, by the people and for the people." People like you and me. Member account number six hundred five thousand two hundred ninety two.

Co-op Light & Power has joined America's electric cooperatives in continuing the Co-ops Vote campaign to help get out the vote and insert issues important to co-ops and our communities into the public discussion. This effort will ensure that our voices are heard loud and clear every day, and especially on the next Election Day.

# Review CLP's Connect/Disconnect/Reconnect Policies

The following contains important information regarding CLP Board Policy II-12, Connection/Service Charge. Please read this information carefully so you understand your rights as a Cooperative Light & Power member.

A \$15 Service Connection Charge is required for any one or combination of the following: connection of new service, change of account from one renter to another, transfer of account to a new buyer/owner, but excluding spousal transfers. An electric account disconnected for non-payment may not be reconnected until the delinquent account and associated charges have been paid or satisfactory arrangements for payment have been made with the CLP's Credit Manager. Member account number six hundred twenty thousand seven hundred two.

A \$50 Collection Call Charge and a \$50 Service Reconnection Charge is required of an existing service that was disconnected due to non-payment. If a service is reconnected after hours, a minimum of a \$250 additional Overtime Charge will be applied. Member account number six hundred eighteen thousand three hundred sixty.

All trips to the member premises under this policy shall be scheduled to occur during regular business hours, unless otherwise stated. For further information on CLP Board Policies, please contact CLP's General Manager, Steve Wattnem at 218.834.2226 or 800.580.5881.

### Elsie's Easy Rhubarb Dessert From the Kitchen of: Elsie Larson

4 cups cut-up rhubarb 1 cup sugar

yellow cake mix (mix 1 as directed on the box) c

1 cup heavy whipping ) cream (un-whipped)

Toss cut-up rhubarb with sugar until coated and set aside. Grease the bottom of a 9 x 13 cake pan. Mix yellow cake mix as directed on the package. Pour cake batter into pan and sprinkle the sugar-coated rhubarb evenly over the cake batter. Pour heavy whipping cream (unwhipped) over all. Bake in preheated oven at 350° for about 40 minutes, until golden brown. I like to invert the pieces with the rhubarb up to serve with a dollop of Redi-whip, Cool Whip, or ice cream. I also freeze cut-up rhubarb in 4 cup portions in quart sized ziplock bags to enable me to make this recipe year round. Enjoy!

A regular meeting of the Board of Directors was held on March 22, 2018. All directors were present at the time the meeting was called to order at 9:44 a.m.

A motion was made and seconded to approve the Operation Round Up Grants as presented after consideration and discussion. Motion carried.

System Attorney, Jeff Dobberpuhl, was on hand via telephone to discuss the remaining issues regarding By-Laws. A motion was made and seconded to accept the changes that were presented and indicated that these By-Laws, with the changes, should be mailed to the Membership in the appropriate time. Motion carried.

Mike Pederson from Esterbrooks,

the auditing firm that CLP uses, was on hand to discuss the most recent audit for the year 2017.

A motion was made and seconded to accept the 2017 audit as presented and printed. Motion carried.

Several board members attended a Deep Dive session on Local Democracy and received good information on how to handle disputes in the future regarding Distributed Generation. A new form, entitled Distributed Generation Dispute Form, will become part of the Distributed Generation Interconnection packet.

There being no further business to come before said meeting, adjournment was called for at 3:50 p.m. with a motion and a second. Motion carried.
