Dear Member:

Political spying, espionage, sabotage. Threats, leaks, obstruction of justice. The plots of all great mystery novels. Except—that they are not mystery novels. They are up close and real life, spread across the front page of every website, magazine, and newspaper we open. From Chernobyl to Enron; big tobacco to the little Pinto; and President Nixon to President Clinton to President Trump. Why do (or can) Heads of States, Fortune 500 Companies, and even Houses of Worship continually cover up their scandals and get away with them. Perhaps the bigger question is, why even do the deed in the first place? Greed? Power? Infamy?

As long as there have been humans, there have been scandals. Whatever reason drives it, it is important to remember one thing, not all humans are evil or corrupt. Let's take the leaders of your electric co-op for instance. Your co-op is governed by a Board of Directors that is properly vetted. Candidates for elected positions are selected from a peer-member group, chosen by you, a co-op member, at your District Nominating Meeting. The candidates are then

brought before the Co-op Annual Meeting and the District Director is elected by the members of that specific District; or, by the entire membership present if a quorum for that district is not available. This democratic process has been applied and accepted by co-ops across the globe, and has proven to be a successful way to fairly and equitably represent each individual member district.

Your electric co-op operates under the 7 Cooperative Principles of Voluntary and Open Membership; Democratic Member Control; Members' Economic Participation; Autonomy and Independence; Education, Training, and Information; Cooperation Among Cooperatives; and Concern for Community. These Principles were developed by the Rochdale Society of Equitable Pioneers in England, in 1844, and have been valued by co-ops ever since that time.

Electric co-ops govern under the notion of what is best for the electric cooperative, and the membership as a whole. This includes having policies, practices, and a culture to facilitate (1) member engagement in, and democratic member control of, the co-op;

(2) fiduciary oversight of the co-ops operations and structure (3) achieving the co-ops vision, mission, and goals; and (4)

acting with integrity, transparency, accountability, and courage. In addition, your electric co-op Board of Directors adhere to a Code of Conduct. Among the long list of criteria, your elected official has agreed to (1) maintain complete loyalty to their electric co-op and actively support its objectives and programs; (2) exercise and insist upon the use of sound business principles in the conduct of the affairs of their co-op; and (3) accept their election as director as a "trust" as well as an "honor" and will not hesitate to relinquish their position as

director if circumstances prevent them from giving complete

(2) fiduciary oversight of the co-ops operations and structure; and full attention to their responsibilities as a director.

Finally, your electric co-op has retained an independent counsel to represent and advise us in legal matters; we have retained a professional engineer to comply with federal and state electrical and safety codes, and to uphold loan covenants; and have retained an independent auditor to ensure we are going about our daily business in accordance with acceptable accounting standards. Member account number six hundred eighty eight thousand three hundred forty two.

This is your electric co-op. Be assured that your elected officials, management, and staff are doing everything to earn your trust and loyalty.

Doritos Taco Salad

1 lb lean ground beef
1 packet taco seasoning
1 head of iceberg lettuce, cho

1 head of iceberg lettuce, chopped into bite sized pieces

1 large tomato, diced

4 oz cheddar cheese, shredded 4 oz nacho cheese Doritos, broken up into bite sized pieces 1 cup Catalina or French dressing

Brown the ground beef in a skillet over medium heat until thoroughly cooked. Add the packet of taco seasoning and stir until well coated. Set aside. In a large serving bowl. combine lettuce, tomatoes, cheese and completely cooled beef. You can also add beans or other vegetables you would like. A regular meeting of the Board of Directors was held on July 19, 2018. All directors were present at the time the meeting was called to order at 9:46 a.m.

A motion was made and seconded to approve the minutes from the meeting held on June 21, 2018, with corrections noted. Motion carried.

A motion was made and seconded to accept the Financial Reports for the month of May 2018. Motion carried.

A motion was made and seconded to accept the Outage Reports for the month of June 2018. Motion carried.

Manager Wattnem gave an update on the loan application progress. The work plan costs were increased by \$481,250, which made the loan application \$5,670,000.

A copy of the most recent power bill motion and a second. Motion carried.

was included in the board packet for the board's information and discussion ensued with some explanations required and given.

Discussion ensued on Louisiana Pacific and the fact that they wish to be able to control the generators themselves should they wish to. Protocols are being worked on as to how this can happen.

CLP had received a proposal to purchase one of the 5-acre plots that the cooperative owns near the Clover Valley Substation. Manager Wattnem was instructed to obtain more information as to what their intentions are for that piece of property.

There being no further business to come before said meeting, adjournment was called for at 4:36 p.m. with a motion and a second. Motion carried.
