Sizing:

- Load calculations on file

Airflow:

- Supply & return dry bulb temperature
- Supply & return wet bulb temperature
- Total external static pressure (IWC)
- Fan speed

Refrigerant charge:

- Liquid line pressure & temperature
- Actual & target subcool temperature
- Suction line pressure & temperature
- Actual & target superheat

Ductwork:

- Check and sealed exposed ductwork

Rebates are available for the purchase of new ENERGY STAR® rated appliances. A new refrigerator or freezer purchase must include recycling of the older, working refrigerator or freezer. Rebate submittal must follow the guidelines as outlined by the cooperative. The cooperative is not responsible for inaccurate information supplied by appliance dealers.
