Guidelines for Petition to Nominate

Pursuant to Section 4.5 of Cooperative Light & Power's Bylaws, Members from **District 3** who are interested in being elected to Cooperative Light & Power's Board of Directors must submit a petition to the Cooperative on or before **January 24, 2027**, which is 90 days before the April 25, 2027, CLP Annual Meeting.

1. The petition must be signed by at **least 15 Members*** with voting rights in that District.
2. A Member may not sign more than one petition except in the case of a joint membership, and in that case, both joint members may sign a petition.

**The member names must appear on the account as applicants or co-applicants. CLP recommends obtaining additional signatures beyond the 15 minimum to ensure that, during the membership validation process, the petition doesn't fall below that threshold.*

The petition will be available on our website at www.clpower.com and at our office located at 1554 Highway 2, Two Harbors, MN 55616. Please submit your petition before the deadline in case any signatures are invalid and additional signatures are required. Completed petitions can be emailed to careyh@clpower.com or dropped off at the Cooperative's office.
