Director Nominating Meetings to be Held

As an electric cooperative, Cooperative Light & Power (CLP) is guided by an elected Board of Directors representing its members' best interests when making important business decisions. Being a member of CLP's board is an incredibly important position in our community. A director's decisions will impact issues such as rates, right-of-way, annual budget, and work plans. This position holds great responsibility and requires individuals who understand their community's needs and serve the cooperative members' best interests.

The CLP Board of Directors consists of 5 directors, with one director representing each of CLP's five districts. Each director is elected for a three-year term with no term limit. The board will elect a director to serve as President, Vice President, Secretary, or Treasurer. Each director shall be a member of this Association and shall be elected by the members at the Annual Meeting of the membership. This year's Annual Meeting will be held on April 17, 2024, at the Two Harbors High School.

Medical Emergency Power

According to Minnesota Statute 216B.098, Subd. 5, a utility shall reconnect or continue service to a customer's residence where a medical emergency exists or where medical equipment requiring electricity necessary to sustain life is in use, provided that the utility receives written certification, or initial certification by telephone and written certification within five business days, that failure to reconnect or continue services will impair or threaten the health or safety of a resident of the customer's household. Certification of the necessity for service is required. Certification may be provided by: (1) a licensed medical doctor; (2) a licensed physician assistant; (3) an advanced practice registered nurse; or (4) a registered nurse. Unless specific criteria are met, a certification may not extend beyond six months from the date of written certification. Chocolate Raspberry Candy From the Kitchen of: Diane MacFarlane

- 1 Bar Ghiradelli 60% bittersweet chocolate
- Chopped pecans
- Fresh raspberries

Break apart and melt 1 bar Ghiradelli 60% cacao bittersweet chocolate in microwave in 30 second increments and watch carefully and do not overheat. Stir until smooth-add chopped pecans. Drop by small spoonfuls onto cookie sheet lined with wax or parchment paper. Set a fresh raspberry in the center of each one. Chill until firm. Store in fridge in covered container-single layers. Makes 20-24, depending on the size.

A regular meeting of the CLP Board of Directors was held on November 29, 2023, with the participation of all directors, CEO Janorschke, five staff members, one member owner, two guests, Jeff Borling from GRE, and CLP's Attorney.

Meeting was called to order at 9:01 a.m. Motions were made and seconded to approve the modified agenda, the modified October minutes, Special Meeting Minutes, consent agenda, and the August financials. Motions passed.

Discussion was held on a proposed hotel development in Two Harbors. The developers are requesting a grant loan from CLP through USDA Rural Economic Development Loan & Grant Program.

Member Geoff Tolley spoke to the Board regarding Hybrids and EV's.

Business Manager Olson updated the Board on the IVM and grant updates.

Member Services/HR Manager Hogenson introduced the new Member Service Representative Brandi Berquist, and she discussed the Rural Electric Youth Tour. A motion was made and seconded to send one student to the 2024 Youth Tour.

Energy Service Manager Jones informed the Board that the EV charger for public use at CLP will be replaced.

Operation Manager Bentler was not in attendance. The Board had no concerns for his written report. CEO Janorschke provided reports and updates from MREA, legislation, and other matters of interest.

President Veitenheimer reported on the GRE Board meeting he attended.

A motion was made and seconded to approve the Resolution on Capital Credit Retirements. Motion passed.

A motion was made and seconded to vote on the GRE Resolution R23-11-7 Certificate of Amended and Restated Articles of Incorporation and Restated Bylaws. Roll call vote. Motion passed.

A motion was made and seconded to approve the 2024 Budget. Motion passed.

A motion was made and seconded to approve the Corporate Debt Limit Resolution. Roll call vote. Motion passed.

The Board agreed to amend the Articles of Incorporation & Bylaws in 2025.

The Board selected dates in May for Strategic Planning in 2024.

The Annual Meeting date is set for April 17,2024. Discussion on how to format the meeting should take place regarding questions and answers.

The Board asked for data to be reviewed on Board meetings and Zoom. CEO Janorschke along with the Board believe that Zoom is good transparency. Next Board meeting date is December 27, 2023. Adjournment was called at 3:32 p.m.
