CLP Earns a Minnesota Safety Council Governor's Workplace Safety Award

Cooperative Light & Power (CLP) was recognized for excellence in workplace safety and health during the 2025 Minnesota Safety and Health Conference held on May 5 & May 6. (CLP is amongst 200 employers to be honored through the awards program, coordinated by the Minnesota Safety Council).

"Keeping the people we work and live with safe is a full-time job," said Paul Aasen, CEO of the Minnesota Safety Council. "Congratulations to CLP for investing the time and energy to make work and life safer inside their organization and beyond."

"This award is a testament to our team's unwavering commitment to safety, not just as a policy, but as a core value that guides everything we do. I'm incredibly proud of every individual who contributes daily to creating a workplace where people feel protected, respected, and empowered. Safety isn't just a goal, it's our responsibility," said CLP CEO Joel Janorschke.



Since 1934, the annual Governor's Workplace Safety
Awards program has honored Minnesota employers
with exceptional safety
performance. Applicants
are judged on several years
of injury data as it compares with their industry's
national and state statistics, and on their progress

in implementing a comprehensive safety program. Winners are recognized at five levels:

-Diamond Achievement (34 winners)

Achieved an incidence rate better than the 97th percentile of both the state and national average

-Platinum Achievement (12 winners)

Achieved an incidence rate better than the 90th percentile of both the state and national average

-Gold Achievement (44 winners)

Achieved an incidence rate better than the 75th percentile of both the state and national average

-Silver Achievement (67 winners)

Achieved an incidence rate better than the 50th percentile of both the state and national average

-Bronze Achievement (43 winners)

Achieved an incidence rate better than the 50th percentile of the state or national average

CLP received a *Diamond Achievement Award* in recognition of its excellence in occupational injury prevention throughout 2024. This marks CLP's fourth consecutive year receiving this award. Member account number seven hundred twenty one thousand one hundred thirty nine.

CLP CEO Joel Janorschke Resigns; Carey Hogenson Appointed Interim CEO

Cooperative Light & Power (CLP) has announced the resignation of Chief Executive Officer (CEO) Joel Janorschke, effective mid-June. Janorschke, who joined the cooperative in October 2022, will be stepping down to accept a new role as CEO of Lake Region Electric Cooperative in Pelican Rapids, Minnesota.

During his tenure at CLP, Janorschke focused on delivering safe, reliable energy to members and spearheaded the development of a comprehensive Integrated Vegetation Management (IVM) program. He worked closely with the CLP Board of Directors to amend the cooperative's Articles of Incorporation and Bylaws and supported efforts to revise district boundaries. His leadership helped position CLP for long-term growth, sustainability, and reliability.

"Joel has been an outstanding leader at CLP, and his dedication to the cooperative model has left a lasting impact," said Roger Peterson, President of CLP's Board of Directors. "We appreciate his service and wish him all the best in his new role."

In preparation for Janorschke's departure, the CLP Board has appointed Carey Hogenson as Interim CEO. Hogenson currently serves as the cooperative's Member Services and Human Resources Manager, bringing over 30 years of dedicated service to CLP and its members.
